



MEMBER RESPONSIBILITY FORM

Regarding the Use of the Association Right-of-Way Road Through the Private Property of Mr. Renato Livinal

All Mont O'Brien members who wish to use the Right-of-Way Road to access the Mont O'Brien region must sign this Acknowledgement. One adult signatory is required per family membership. This person is responsible for all members of their family are aware of and abide by the conditions of this Member Responsibility Acknowledgement.

I, _____, acknowledge that my membership in the Mont O'Brien Association provides me with access privileges into the Mont O'Brien region due to a Right-of-Way Agreement which was signed on my behalf by the President of the Mont O'Brien Association. I understand that Mr. Renato Livinal has generously provided this Right-of-Way to the Mont O'Brien Association. I know that the Right-of-Way extends south from Route 301 on a designated road, built by Association volunteers, through Lot numbers Twenty, Twenty-one and Twenty-two (20, 21 & 22) in Range Two (2), in the Township of Alleyn, Municipality of Alleyn-and-Cawood, County of Pontiac, Quebec.

I, _____, further acknowledge that as a member of the Mont O'Brien Association in good standing, I am entitled to use this Right-of-Way Road only as long as my membership dues are paid in full and only as long as I abide by the following rules:

- i. **I agree to close and lock the gate**, located at the entrance off of Route 301, behind me as I enter and exit the Mont O'Brien region. Even if I may find the gate unlocked and open, I will close and lock it securely behind me.
- ii. I agree to use only the following modes of transportation along the Right-of-Way Road: foot, bicycle, dirt bike, All Terrain Vehicle (ATV), car or pick-up truck. iii. If I use a motorized vehicle, my speed will not exceed 30 km/hour.
- iv. I will only access the Mont O'Brien region via the designated Right-of-Way Road. I will not venture off the Right-of-Way Road and onto private property. I realize that if I leave the Right-of-Way Road for any reason, it is considered trespassing. I will also not park my vehicle or loiter on the section of the Right-of-Way Road which crosses the Livinal property.
- v. I will not engage in any form of hunting either from the Right-of-Way road or on the Livinal property.
- vi. If I am transporting firearms and/or other hunting equipment through either the Livinal property or the Mont O'Brien region, I will do so in a safe and secure manner according to the laws of Canada and the Province of Québec.
- vii. I will not leave any garbage, cigarette butts or any other material either on the Livinal property or in the Mont O'Brien region.

viii. I will not remove any natural resources from the Livinal property.

ix. I agree not to lend my key to anyone other than the following members of my own immediate family who are part of my family membership:

x. I realize that I am permitted to take occasional guests into the Mont O'Brien region via the Right-of-Way Road. However, I recognize that if any of my extended family, friends or acquaintances wish to obtain frequent access into the Mont O'Brien region, I will encourage them to join the Mont O'Brien Association.

xi. I also recognize my responsibility to report any problems I see or encounter to a member of the Association's Board of Directors.

xii. I, _____, further acknowledge that I am signing this Member Responsibility Acknowledgement on behalf of my immediate family members as well as on behalf of any guests that my immediate family that I may invite into the Mont O'Brien region.

xiii. While I am travelling along the Right-of-Way Road, I agree to show proof of my membership, by way of my current membership card, to any other current Mont O'Brien Association member who requests to see it. I also recognize that, if I choose, I too may ask to see proof of membership from others using the Right-of-Way Road.

Furthermore, I acknowledge that any inconsiderate or irresponsible behaviour on my part (or on the part of my family and guests) could jeopardize the Mont O'Brien Association's Right-of-Way Agreement as well as the use of the Mont O'Brien Biodiversity Reserve for my community. I understand that if I am found to be abusing the privileges provided to me as an Association member, my membership will be revoked and my Right-of-Way access privileges into the Mont O'Brien region will be withdrawn.

In closing, I also acknowledge that I am responsible for my own well-being (and that of my family and guests) both on the Right-of-Way Road and in the Mont O'Brien region. I realize that I can not hold the Mont O'Brien Association, its Board of Directors or Mr. Renato Livinal responsible in any way for any misfortune or accident that may befall me as I use both the Right-of-Way Road and the Mont O'Brien region.
